



Setting Up an Account in TreasuryDirect

To set up an account in TreasuryDirect, follow these steps:

- 1** Open your Internet browser (for example, Internet Explorer) and type www.treasurydirect.gov in the address window.
- 2** On the TreasuryDirect home page, under the "Open an Account" section, select "TreasuryDirect."
- 3** Read the three steps on the "Open an Account" page.
- 4** To open an Individual TreasuryDirect account, make sure you have these things:
 - ▶ A taxpayer identification number or a Social Security number.
 - ▶ A United States address of record.
 - ▶ A checking or savings account.
 - You'll need to know your account and routing numbers.
 - ▶ An e-mail address.
 - E.g., YourName@abc.com
 - ▶ A web browser that supports 128-bit encryption.
 - The site is optimized for Internet Explorer.

5 Once you have gathered what you need, click the "Apply Now" button at the bottom of the screen.

6 Choose "Individual" as the type of account you would like to open and then click "Submit."

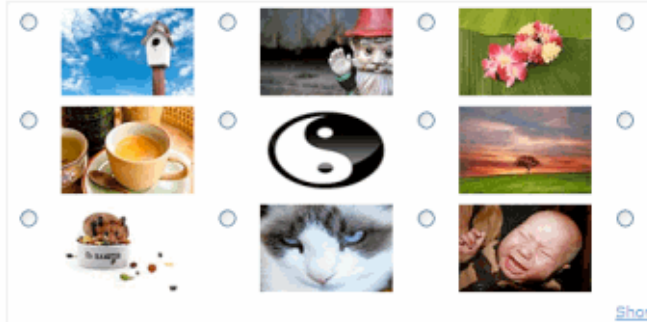
