# Changing the Downtown Skyline

As construction nears completion, WestStar Tower continues to change the look of the downtown skyline. With an anticipated opening date in summer of 2021, the building is taking its final shape.

The 20-story, multi-tenant, multilevel LEED® certified "Green Building," will be the tallest building in El Paso at over 313 feet high. The overall project will include approximately 264,000 rentable square feet of true Class-AA space and 12,000 square feet of ground-level office and retail space. The building will offer approximately 850 parking spaces. Tenants will include, WestStar, Hunt Companies, Hub International, W Silver Recycling, and Windstar, with restaurants Sushi Itto and Corralito Steak House on the ground level. The WestStar downtown branch will relocate from its current location to the ground floor lobby of the Tower. Stay tuned! We will keep you posted on the opening date!
