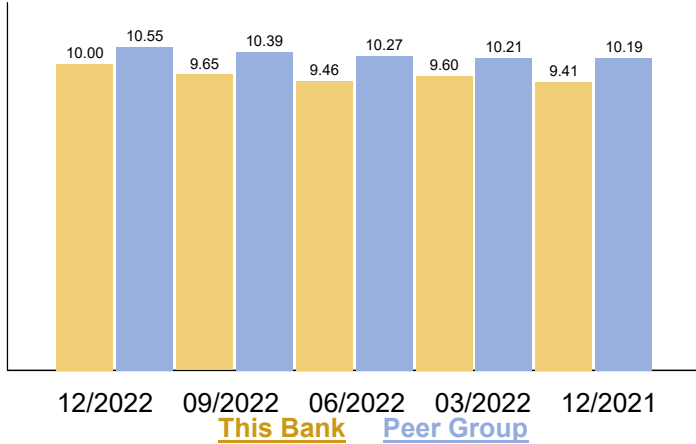

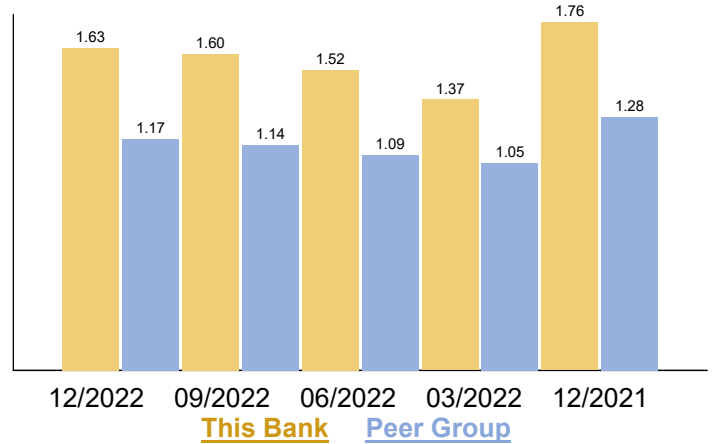
**Leverage Capital Ratio**

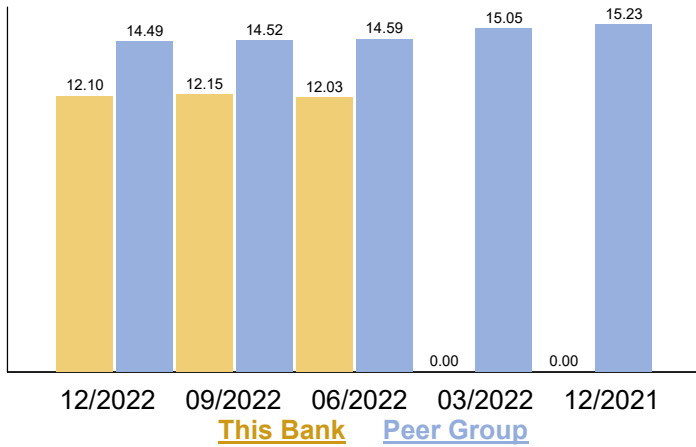
**Return on Assets (annualized)**

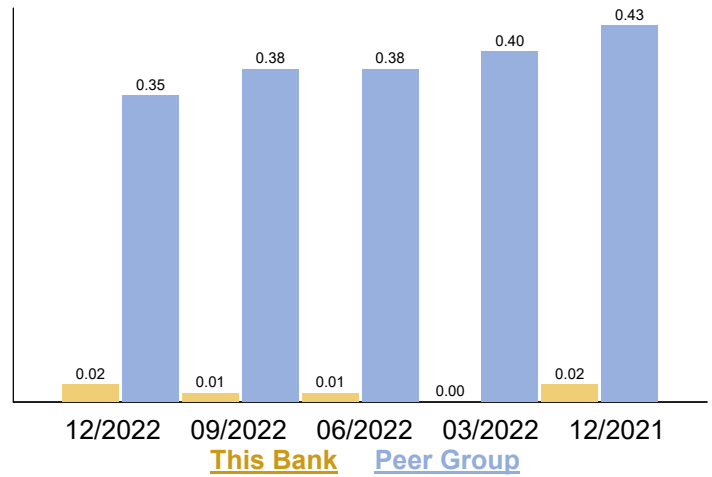


**Risk-based Capital Ratio**
